ANNUAL REPORT 2015

The Year in Review

Island Heritage Trust is a LAND TRUST. The core purpose of the Trust is to conserve land and the natural and human resources dependent upon it. 2015 saw the purchase of the Pickering parcel on the Lily Pond (next to the beach), this will provide more parking for beachgoers, and eventually, toilet facilities. Land for Maine's Future is a partner in this project, and will be making its contribution this summer (now that the bond issues are moving ahead). In the same month, thanks to the initiative of its neighbors, Whig Island joined the Trust's collection of protected islands. In both these cases, the owners generously offered the Trust the properties as bargain sales (ie below appraised value), so a big thank-you goes out to Clara Pickering and her family, and to Chandler and Nita Barbour for their far-seeing vision for the future of our island.

During 2015, the Trust accepted two more Conservation Easements also. This brings our total number of easements to 33 protecting more than 800 acres. These properties are protected from development, but are not generally open to the public. But open or not, they protect many stunning views around our island. If you are wondering why some beautiful view does not have a house in the middle of it, perhaps it is because it is protected by an easement!

The Island Heritage Trust Environmental Education program swung into full action this year. Martha Bell became a real presence in the Elementary School as the Trust's programs were welcomed by the teachers. Martha's talents are being called on to assist the Elementary school as



it too shifts to Project-Based Learning. The new principal, Carla Magoon, is a big fan of IHT and Martha Bell, and loves what we are doing for the teachers and students. The Trust – through Martha – continues to play a major role in the High School's Marine Studies Pathway. Martha assists with the design and implementation of field studies in this innovative program. On other fronts, the Program Committee and the Environmental Education Program teamed up to

provide special programs for our youngest supporters – Kids in Nature Programs were a big hit, and will continue this summer. An after-school Nature Club based at Deer Isle-Stonington Elementary School has attracted a solid following. Many thanks go to Jane Osborne for helping to facilitate these programs.

A Board Retreat in October led to a "re-branding" effort. The Mission Statement was tweaked and education made an official part of the Trust's mandate. The logo also underwent a minor revision, and the stationary got a new look. All this in an effort to make the Trust more accessible, more approachable as we seek to work more closely with our island community.

The Stewardship position was filled and then we lost a good worker to full-time work. Another search brought David Vandiver to the Trust. After a lot of searching, and a false start, we have a Stewardship Director who is eager to work and to learn and will be a great asset going forward. David has a real passion for the Maine outdoors, and has taken ownership of the Trust preserves!

2015 Stewardship Committee Annual Report (November 1, 2014 to October 31, 2015)

The most important function of this committee is to insure that IHT complies with our legal responsibility to manage for public benefit our 34 Conservation Easements which protect 835 acres and our 23 owned properties which protect an additional 483 acres. The total protected shoreline now stands at 21.7 miles and includes 20 islands! This large effort involves IHT Staff and many volunteers. Two of the Preserves, Settlement Quarry and the State owned Tennis Preserve, have “Friends of” groups to assist with management which are a huge help in carrying out day-to-day summer operations. A “Friends of Shore Acres” is being developed to support stewardship efforts there. In the future, it is hoped that all the IHT Preserves which are used heavily by the public during the summer will have “Friends of” groups composed of volunteers.

Beyond IHT’s primary stewardship effort, the Stewardship Committee coordinated other diverse activities. Following the recent big storms of 2014 and 2015, there has been continued repair damage to trails, and an additional Emergency Response Plan is being developed to cover all Preserves. Despite the Governor holding up LMF funds awarded to IHT for its efforts to develop recently acquired properties adjacent to the Lily Pond, some work has been initiated.

During this year, IHT said farewell to Stewardship Director, Janna Newman, who took a full time position with the Ellsworth City Planning Department. Among other tasks, Janna initiated a process to create Work Plans for IHT’s Preserves to guide volunteer efforts. IHT welcomed David Vandiver as Stewardship Director in October, 2015. He is a welcome addition to IHT staff.

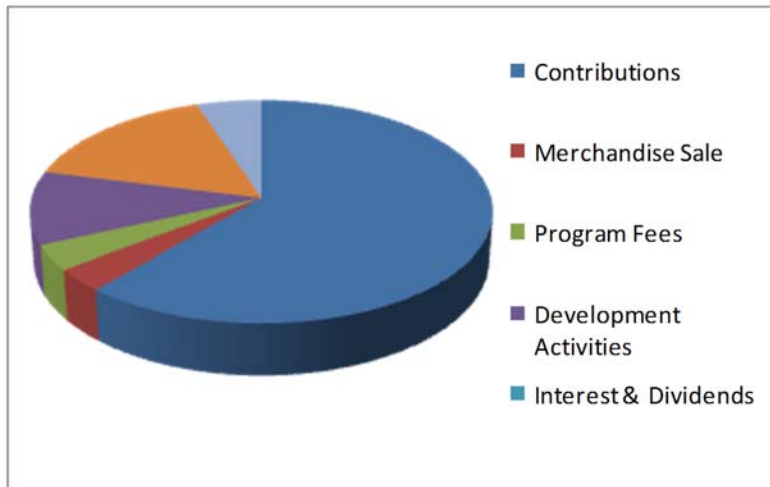

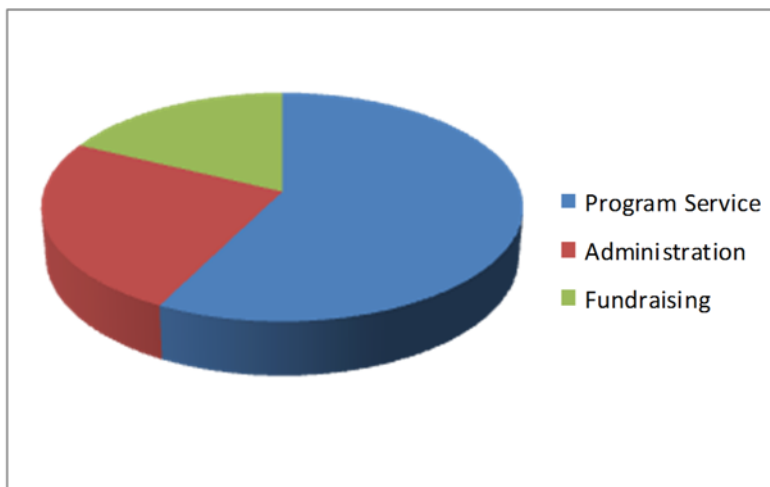

• **Land Committee Report 2015**

- It was a busy year for the Land Committee. Mark Picton joined as a third dual member with Stew Comm. David Vandiver replaced Janna Newman as Director of Stewardship.
- The **purchase** in June of the Pickering lot, aka LP (10 acres, 480 ft), was accomplished without Land for Maine's Future funds which were withheld by Governor LePage, but may yet be released.
- Project to **purchase** Whig Island (2 acres, 482 ft.) with funds from interested citizens as bargain sale from Chandler Barbour was completed in early summer.
- **Acquisition by donation of fee title.**
- In June the committee voted to recommend accepting from the Tolman family two parcels on Little Deer I., a large interior parcel comprised of 45 acres woodland, meadow, and wetland and a ½ acre parcel on Blastow Cove. Providing water access is especially important to the family. Survey is in progress.
- Project to accept from Homann family title to 5.5 acres on Inner Harbor was approved in July and completed in December, to be known as the Crystal Cove Preserve.
- Acceptance of 47 acres with 2-300 on Lily Pond, formerly owned by the Deer Isle-Sunset Congregational Church has been approved pending offer from Andy Rosenthal, who recently purchased property.
- **Conservation Easements.**
- Both the Broshek and Hitz easements were **signed**, thereby protecting 14 acres and 2180 contiguous feet of shoreline on Inner Harbor as well as providing a Harvester Access. The Board approved a request from Mary Ann Broshek to delay her stewardship contribution.
- Easement from Andrew Rosenthal on former Zoe Scott property comprising ca. 13 acres and 956 shore feet on Lily Pond was approved; but grantor is revising building envelope before signing.
- Harvester access easement from Willard Stinson at head of Crockett Cove was approved in July and survey, conservation plan and draft deed have been completed.
